

Operator will implement best management practices to contain any unintentional release of fluids. Fresh water for the Fresh Water Storage containment comes from a water provider, water sources permitted for consumable industrial use.
Construction	Operator has designed the well pad with insloping and a storm water control ditch to prevent storm water run-off/run-on and the release of fluids for the location.
