#### COMMENTS:

Chevron intends to MIT the subject well and to Temporarily Abandon the WMFK pending further evaluation of possible recompletion in the WSTC. The subject well is currently completed in the WMFK and has been found to be in communication with an adjacent well on the SKR 598-25-BV pad and was subsequently shut-in April of 2011.

Per the Condition of Approval attached to a previous Sundry Notice, approved 03/18/2013 (document # 1699283), Chevron is hereby submitting a well work program and schedule for the subject well. Work procedure and Well Bore Diagram are attached.

WMFK TA and MIT have been scheduled for 05/14/2013. Form 42, Notice of Notification, for MIT was submitted on 04/30/2013

Chevron will file the appropriate Forms for approval to Abandon the WMFK and recomplete in the WSTC at a later date as recompletion plans are finalized.
