



NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that wells drilled in excess of 2,500 feet in depth be located not less than any lease line, and located not less than 1,200 feet from any other producible gas well when drilling to the same common source of supply. Section 4, Range 60 West, 6th P.M. is subject to this Rule for the Niobrara Formation.

On December 13, 2012, Condor Energy Technology, LLC ("Condor" or "Applicant"), by its attorneys, filed with the Commission pursuant to §34-60-116 C.R.S., a verified application for an order to establish an approximate 640-acre exploratory drilling for the below-described lands ("Application Lands"), and approve up to four holes in the unit, for the production of oil, gas and associated hydrocarbons from the unit, with the treated interval of the wellbore to be located no closer than 600 boundaries, and no closer than 150 feet from the treated interval of any other well in the unit, without exception being granted by the Director:

Township 6 North, Range 60 West, 6th P.M.
Section 4: All

Applicant requests the Commission approve up to four well pads to be located anywhere within the spacing unit.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under § 34-60-105 C.R.S.; 2) the Commission's Series 500 Rules at 2CCR 404-1, that the Commission scheduled the above-entitled matter for hearing on:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems proper to protect the health, safety and welfare of the public and to prevent the waste of oil, gas, or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of the application should file with the Commission a written protest or intervention on or before January 28, 2013, briefly stating the basis of the protest or intervention. Such interested party, at the time of filing the protest or intervention, should serve a copy of the protest or intervention to the person filing the application and 13 copies shall be filed with the Commission. Anyone who files a protest or intervention shall be able to participate in a prehearing conference during the week of January 28, 2013. Pursuant to Rule 503.b, if a party who has received notice under Rule 503.b wishes to receive further notice of the above-referenced matter, that party must file a protest or intervention in accordance with the rules of the Commission, should no protest or intervention be filed in this matter by January 28, 2013, the Applicant may request that an administrative hearing be scheduled during the week of January 28, 2013. In the alternative, pursuant to Rule 503.c, if the matter is uncontested, the applicant may request, and the Director may recommend a decision on the merits of the verified application and the supporting exhibits.
