COMMENTS:

OXY USA WTP LP (Oxy) is providing this sundry notice as formal closure documentation of the temporary produced water transfer operations conducted between Oxy and WPX Energy (WPX). The Oxy and WPX water transfer agreement was approved by the COGCC on May 24, 2012, reference document number 2224710. Closure documentation is required under the conditions of approval. This plan allowed the transfer of produced water from WPX's TR 41-35-597 / #2 Multi-well Pit (Facility ID 422272) to Oxy's Pond G produced water storage pond via water pipeline. Oxy submitted a sundry notice on October 23, 2012 which requested to utilize the existing water transfer agreement for an additional 90 days.

No transfer of produced water occurred in 2013. A total of 32,256 bbls of produced water was transferred from WPX to Oxy between May and June of 2012, which was previously reported within the annual transfer summary sundry notice submitted to the COGCC on January 8, 2013.
