COMMENTS:

As a follow-up to a NOI SN (attached) previously submitted to COGCC on 10/3/12 for same site, MEP is hereby providing the attached 910 std lab report and summary spreadsheet as required by COGCC, and based on those results is requesting permission to bury the subject frac sand used on site in a trench as previously-described (see approved BLM SN, attached). The sand will be buried under 3' of fill.

PROCEDURE: The samples were collected on 4/22/13. Two 4-point samples were collected and individually composited by OA from the frac sand which was deposited to the trench. Each composite was collected using a soil auger at at depth of 2"-6" below ground surface. The two composite samples were transferred to 16-oz. glass jars for overnight shipment under proper chain of custody to the laboratory for analyses.
