



WELL LOCATION CERTIFICATE

Lat40°, Inc. has determined the surface location of the ROHN STATE LD09-66HN to be 1725' from the NORTH line and 480' from the EAST line and the bottom hole to be 1980' from the NORTH line and 660' from the WEST line as measured at right angles from the section lines of Section 9, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 11/29/2012, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.




