Dear Mr. and Mrs. Drieth:

Encana Oil & Gas (USA) Inc. ("Encana") has staked the above mentioned wells at surface locations as indicated above from the section lines of Section 6, Township 3 North, Range 68 West (see attached Well Location Certificate). These wells are drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 603.a. Statewide Setbacks. This rule states:

- (2) A well shall be a minimum distance of one hundred fifty (150) feet from a surface property line. An exception may be granted by the Director if it is not feasible for the operator to meet this minimum distance requirement and a waiver is obtained from the offset surface owner(s). An exception request letter stating the reasons for the exception shall be submitted to the Director and accompanied by a signed waiver(s) from the offset surface owner(s). Such waiver shall be written and filed in the county clerk and recorder's office and with the Director.

The wells were staked at locations between 115' and 145' North of your property line. Encana respectfully requests your consent to an exception location for these wells by waiver of the COGCC Rule 603.a (2).
