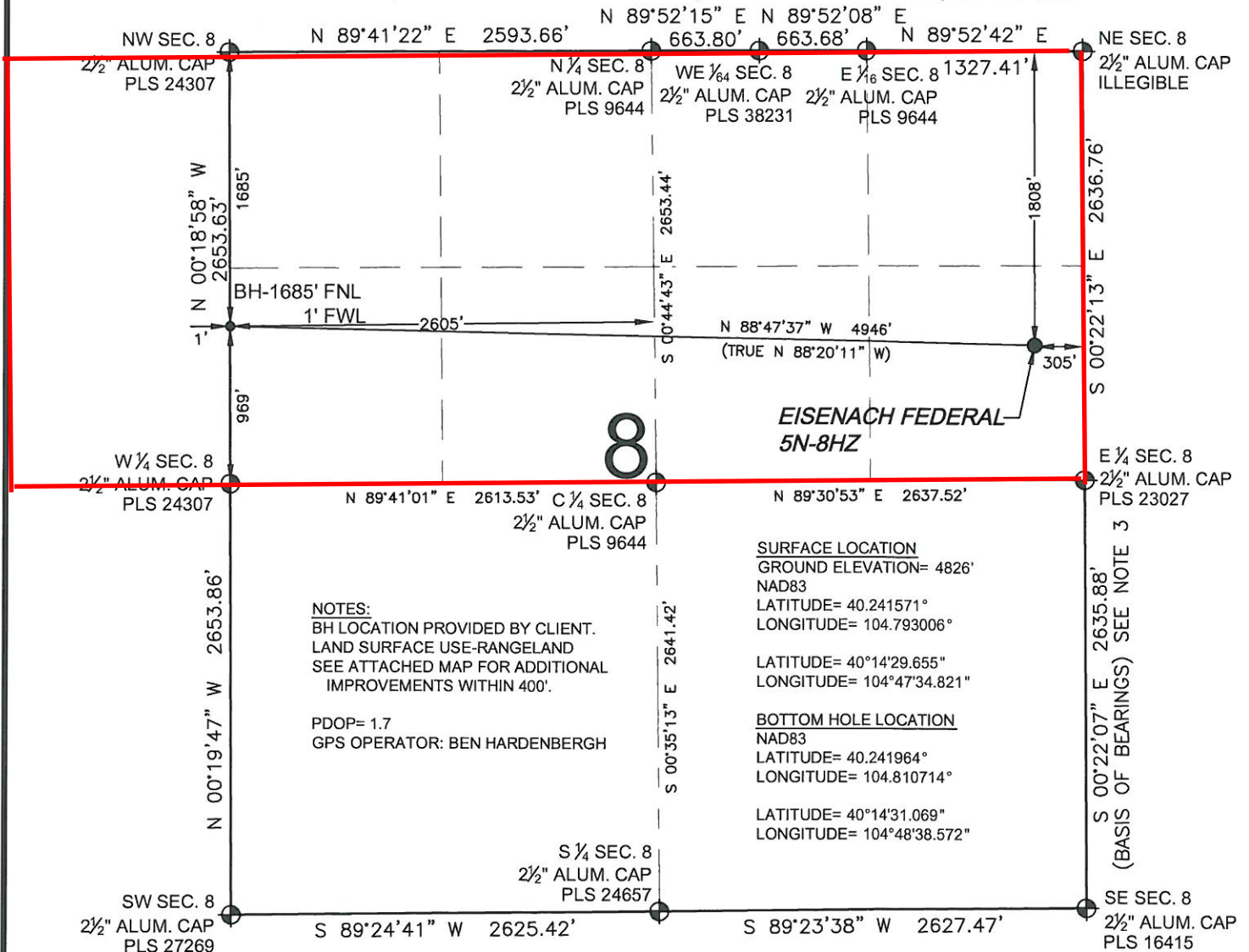

WELL LOCATION CERTIFICATE: EISENACH FEDERAL 5N-8HZ

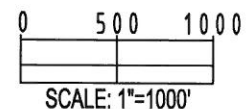
