Two NRCS Map Unit Descriptions and Plant Compositions have been included. The location is very near Map Unit Description 129. The closest water well (Receipt No. 3632798C) is approximately 9,290' from the location. The closest water well with depth to groundwater information is approximately 20,475' (Receipt No. 9090398) from the location. The location was marked as sensitive due to the depth to groundwater. An Alternate Production Facility Layout has been included in the filing so the COGCC can evaluate the alternate production facility location at the same time they review the anticipated production facility location. The plat was generated to allow flexibility on placement of the production facilities for both Aurora Power and the surface owner if necessary.
