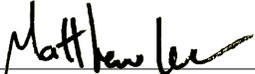
### 15. Comments:

Nearest water well (cancelled permit) 2855' NW is a domestic well; Receipt #0903362, Permit #40248 with an unknown depth and static water level. Permit #211576 used for static water level. The reference area is on undisturbed ground immediately adjacent to and North of the facility location as shown in the location photo facing North. An updated reference photo will be provided during growing season. Location is the production facilities for the proposed Vigilant State AC16-03 (Doc #400403113), Vigilant State AC16-05 (Doc #400403115), and Vigilant State AC16-06 (Doc #400403117). Access road follows existing access into Section 15, and uses old reclaimed pathways across Section 16.
