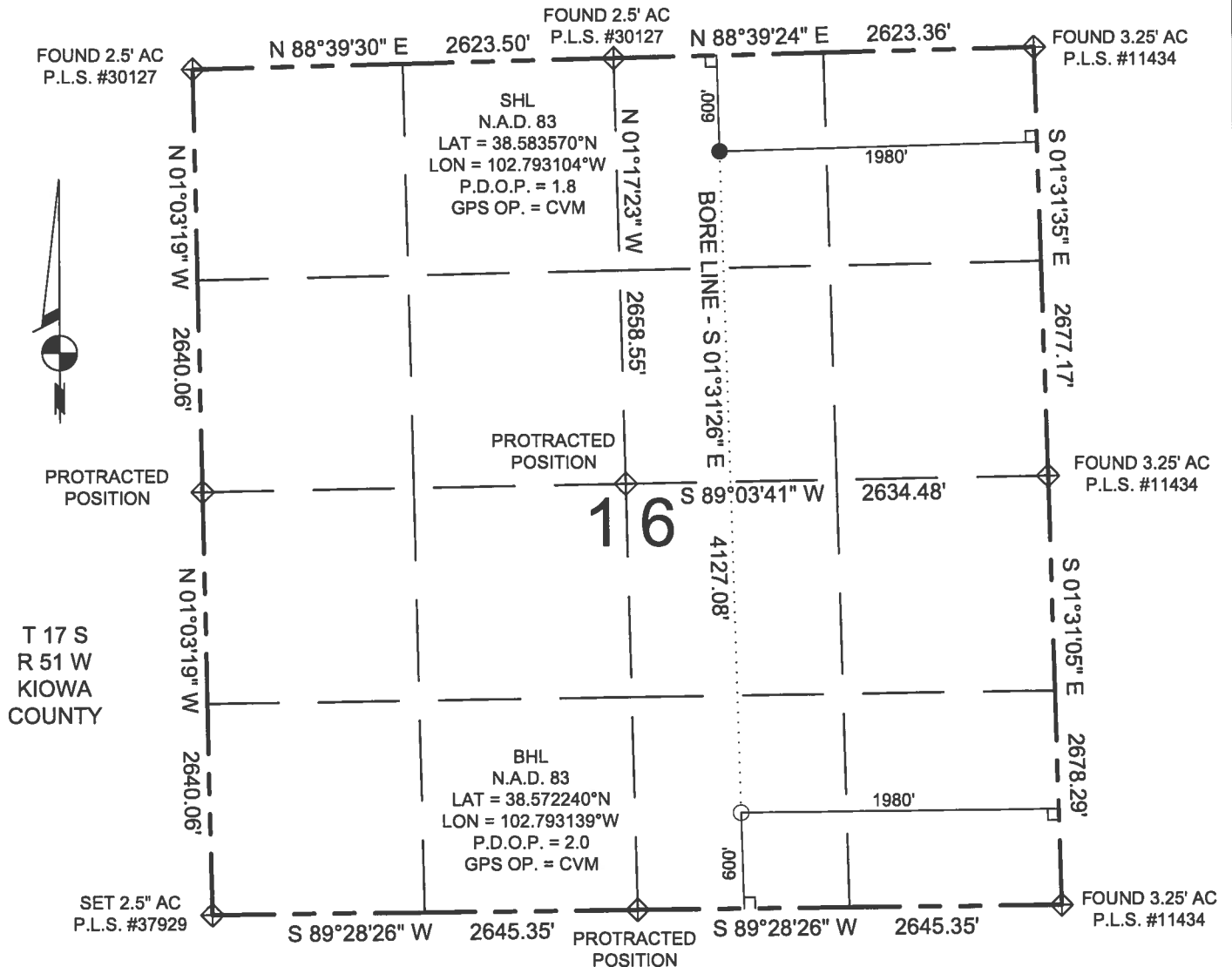


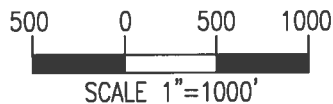
# LOCATION PLAT MC BRYDE STATE 16-17-48 #1H

- PROPOSED BOTTOM HOLE LOCATION

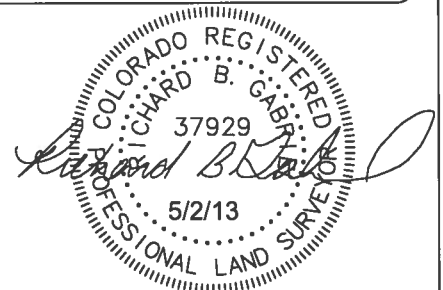


## NOTES:

3. THE BEARINGS AS SHOWN HEREON ARE BASED ON GPS OBSERVATIONS BETWEEN THE MONUMENTS SHOWN HEREON AS FOUND IN THE FIELD DATE BELOW.
