Verbal Approval: Granted by Diana Burn (COGCC) at 3:58pm 05/28/2013

While drilling the lateral hole interval at a depth of 12,127' tight hole conditions were experienced and the decision was made to trip out of the hole. A reaming BHA was picked up and run in hole to improve hole conditions prior to running the production liner. During the reaming operations tight hole was experienced at 10,760', working the drill string it was determined that the borehole had collapsed. A review of the seismic and LWD data indicated this was where the wellbore had crossed a 113' fault and come within 10' of the Sharon Springs formation. A second attempt to clean the hole was made with a motor and bit but was found to be unsuccessful resulting in erratic torque and drilling parameters posing a risk of sticking the BHA downhole.

The decision was made to perform an open hole sidetrack to re-drill the remaining 1,750' of lateral. The depth providing the highest likelihood of success for the side track was located at 9,645'MD, 7,204' TVD. The plan forward will be sidetrack below the current wellbore to cross the fault in more competent rock and re-drill the additional 1,750' in the Niobrara B/C bench.
