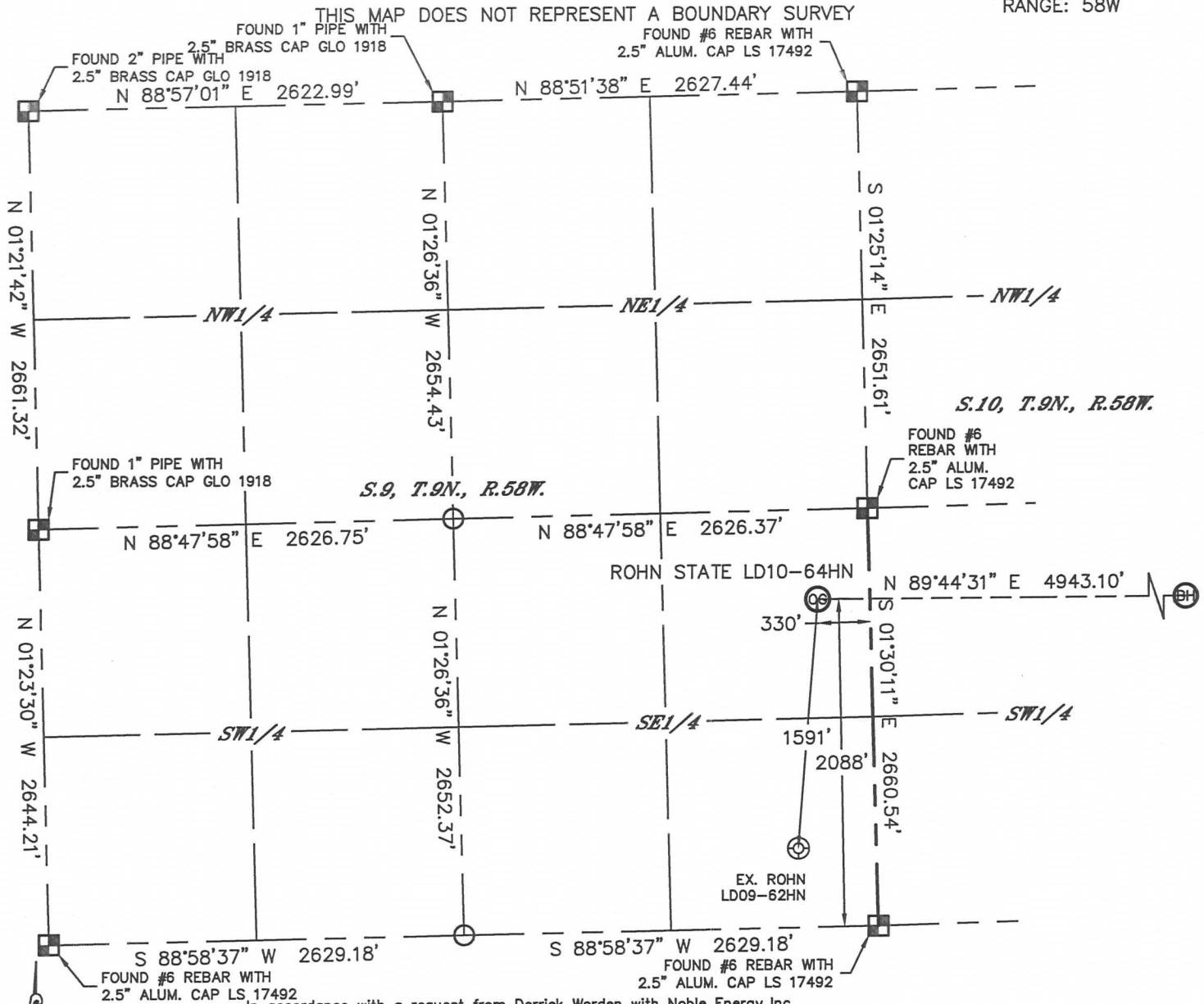


# WELL LOCATION CERTIFICATE

In accordance with a request from Derrick Worden with Noble Energy Inc., Lat40°, Inc. has determined the surface location of the ROHN STATE LD10-64HN to be 2088' from the SOUTH line and 330' from the EAST line as measured at right angles from the section lines of Section 9, Township 9 North, Range 58 West of the Sixth Principal Meridian and the bottom hole to be 1980' from the SOUTH line and 660' from the EAST line as measured at right angles from the section lines of Section 10, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 11/29/2012, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

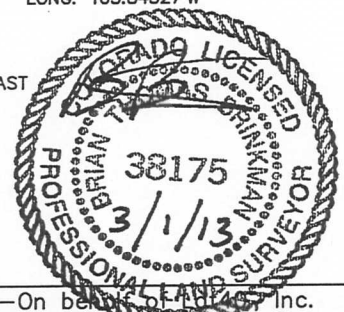

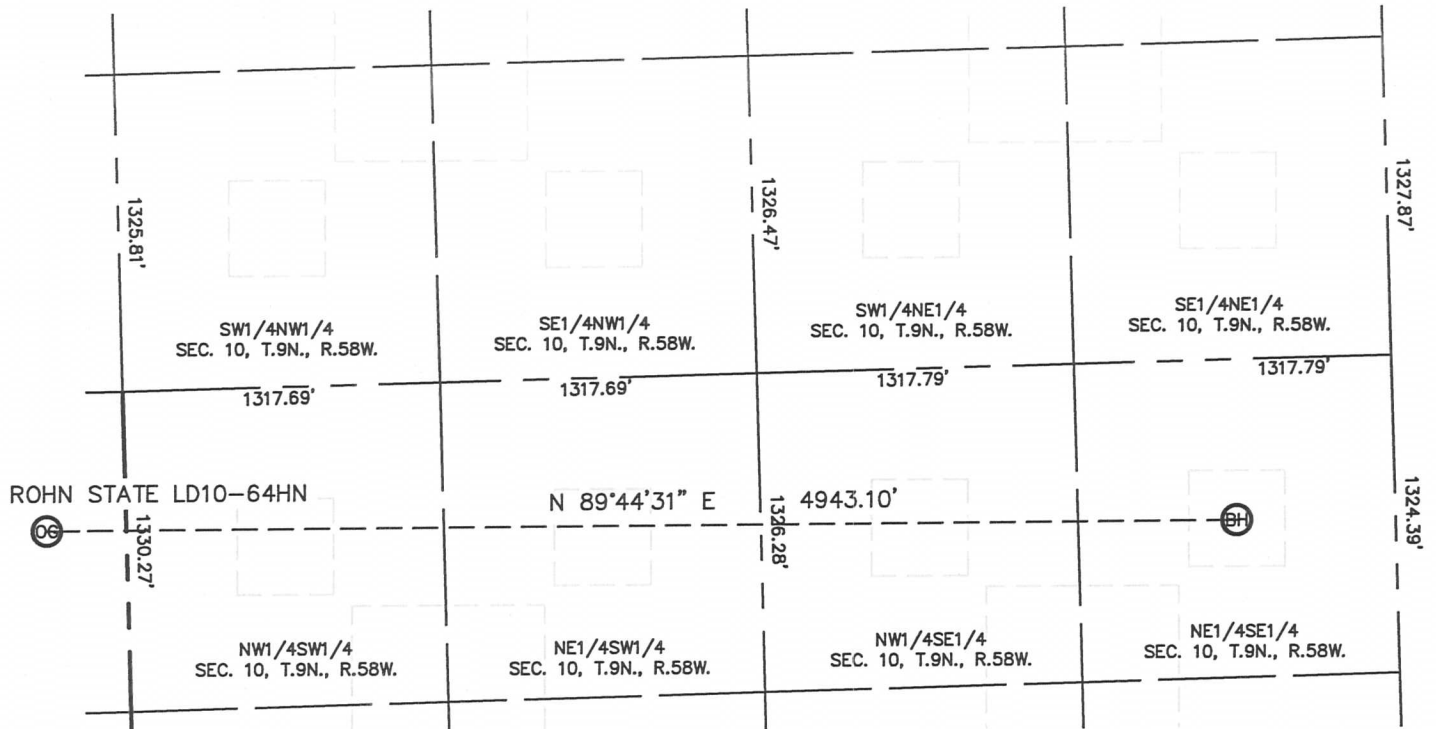
