THIS WELL HAS BEEN BUILDING BRADENHEAD PRESSURE SINCE 4-30-13. IT HAS BEEN BLOWN DOWN APPROXIMATELY EVERY OTHER DAY SINCE THE FIRST WEEK OF MAY IN ORDER TO KEEP THE PRESSURES BELOW 150 PSI.

ENCANA REQUESTS APPROVAL TO CONTINUOUSLY VENT THE BRADENHEAD ON THIS WELL UNTIL COMPLETION OPERATIONS COMMENCE WHICH PLANNED IN THE NEXT 90 DAYS.

DURING COMPLETION OPERATIONS ENCANA WILL MONITOR THE BRADENHEAD PRESSURE CONTINUOUSLY AND IMMEDIATELY REPORT CHANGES IN THE BRADENHEAD PRESSURE VIA EMAIL. AT THE END OF COMPLETION, ENCANA WILL CONDUCT A 3-DAY BRADENHEAD PRESSURE BUILDUP AND REPORT THE DATA VIA SUNDRY NOTICE.

ENCANA WILL CONTINUE TO MONITOR THE SEVEN REMAINING WELLS ON THIS PAD AND, IN THE THE EVENT OF BRADENHEAD PRESSURE BUILDUP, WILL SUBMIT CONTINUOUS VENT REQUESTS AS NEEDED.
