Comments:

16" steel conductor has been set to 97' with cement. 14" steel pipe has been set at 75' for the mouse hole. A 40' rat hole was set with 16" steel pipe. All pipe will be cut 5' below surface, filled with 4 – 5 bbls of cement, topped off with sand and gravel from the location and capped. Hilcorp will stencil all three plates and remove the cellar ring. Once the work is complete Hilcorp will immediately begin final pad reclamation. Hilcorp will not drill this location
