COMMENTS:

Encana requests the approval of a temporary water storage facilities location that would place three 150' diameter water storage tanks next to the existing 5 acre well site location and add 4 acres for a total of 9 acres of total surface disturbance. The location (ID #431829) is on cropland.

The surface owner has given their verbal aproval and the agreement is attached with this sundry.

Encana will be setting a fire hydrant near the location to be used to deliver water via surface pipeline to the tanks. CTB water shares have been purchased from A&W as the water source.

Encana will agree to the following as conditions of approval for this temporary water storage location:

1. Large volume temporary storage tanks will not be placed on fill material.
2. Only fresh water is permitted to be stored in large volume temporary storage tanks; flowback or prouduced fluids shall not be placed in large volume temporary storage tanks.
3. Any tanks containing flowback and/or produced fluids shall be placed on a sufficiently impervious area of the pad with adequate secondary containment.

Estimated location construction would begin June 1, 2013 and the tanks would be removed immediately after the frac operations are completed.
