The above referenced wellbore is being evaluated for uphole recompletion in the Fruitland coal formation.

The well previously served as an injection well for TS4; the Entrada injection interval was P&A'd in December 2010; TOC was tagged at 7672' during the P&A procedure.

A Mechanical Integrity Test was performed on the wellbore on 4/25/13

Per the COGCC procedure approved 12/16/2009, BP planned to:

Set a 7" CIBP @ ~7848'

Run Eline logging (RST & CBL) in the 9 5/8" casing

Evaluate the Fruitland for future recomplete.

MIRU 5/1/13

Attempts to cut the tubing and set the 7" CIBP @ ~7600' were unsuccessful.

The COGCC was informed that the procedure in the approved sundry needed to change to move the cut point for the 3.5" tubing cut uphole to 5370' and CIBP at 5300' Verbal approval was received.

3.5" tubing cut at 5350'

7" CIBP set at 5300'

Capped with 5' of dump bailed cement

Logs run

RDMO 5/10/13

The MIT was sent to the COGCC on 6/3/13.
