Well distance to nearest spacing unit boundary = 460'. Operator notified on 04/17/13 the owners as defined in C.R.S. §34-60-103(7) within the proposed spacing unit and received a signed no-objection letter. The signed waiver is attached. Operator requests a rule 318A(a) and 318A(c) exception location; this well surface location is outside the GWA drilling windows and is greater than 50' from an existing well. Rule 318A(a) and Rule 318A(c) request and waiver are attached. Drilling/Completion Operations	Anti-Collision BMP: Prior to drilling operations, Operator will perform an anti-collision scan of existing offset wells that have the potential of being within close proximity of the proposed wells. This anti-collision scan will include definitive MWD or gyro surveys of the offset wells with included error of uncertainty per survey instrument, and compared against the proposed wellpath with its respective error of uncertainty. If current surveys do not exist for the offset wells, Operator may have gyro surveys conducted to verify bottomhole location. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision, or harm to people or the environment. For the proposed well, upon conclusion of drilling operations, an asconstructed gyro survey will be submitted to COGCC with the Form 5.
