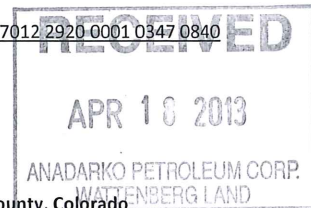

PAVISTMA SOUTH 1 #1-5-32-090-4-NH Well: 1665' FSL, 200' FWL, Sec. 32-T6N-R67W, Weld County, Colorado

Dear Working Interest Owner,

Tekton Windsor, LLC (TW), intends to propose, drill and operate the above referenced East-West trending well pursuant to Rule 318A(a).4.(D) of the Colorado Oil and Gas Conservation Commission (COGCC). The well is planned in accordance with the wishes of Kerr-McGee pursuant to discussions with TW. TW will propose the well as follows:

- 1. Surface and Bottomhole Locations:**
SHL: 1665' FSL, 200' FWL, Sec. 32-T6N-R67W
Top of Producing Zone Location: 1845' FSL, 460' FWL, Sec. 32-T6N-R67W
BHL: 1845' FSL, 460' FEL, Sec. 32-T6N-R67W
- 2. Wellbore Spacing Unit:**
The wellbore spacing unit will consist of the 320-acres comprising the S/2 of Sec. 32-T6N-R67W. The well spacing unit is depicted on the enclosed plat.
- 3. Target Formations and Geologic Statement:**
This well is planned as a NIOBRARA horizontal, and the well will be drilled to a sufficient depth and reach in order to test the viability of said formation.
- 4. Anticipated Spud Date & Surface Use:**
The anticipated spud date for this well is June 01, 2013. Currently the surface is cropland.

Pursuant to COGCC Rule 318A(e).6, you have thirty (30) days from receipt of this notice to object to this proposal. In the event you do not respond to this notice or enter an objection within the established time period, the proposed 320 acre spacing unit set forth herein shall be established. However, should you have no objection to this proposal; your cooperation of a written reply would be greatly appreciated in the form of the enclosed 30-day waiver below.
