Dear Gentlemen

Tekton Windsor, LLC (TW) is applying to the Colorado Oil and Gas Conversation Commission (COGCC) to drill the above referenced well at the described surface and bottom hole locations. Per COGCC Rule 318A.m, no horizontal wellbore lateral shall be located less than one hundred fifty (150) feet from any existing or permitted oil or gas wellbore unless waived in writing by the operator of the encroached upon well. As currently planned, the horizontal wellbore lateral of the above well will lie within 150 feet of the wellbore of the captioned wells:

Pavistma #11-32, API 05-123-26006, Operated by Kerr-McGee Oil & Gas Onshore LP

Pavistma #12-32, API 05-123-26007, Operated by Kerr-McGee Oil & Gas Onshore LP

Per COGCC Rules TW is required to get the affected operator's approval in writing and a waiver of said Rule 318A.m. The well is planned as above at your request to maximize mineral recovery. Also enclosed is a Well Location Plat that shows the planned wellbore.
