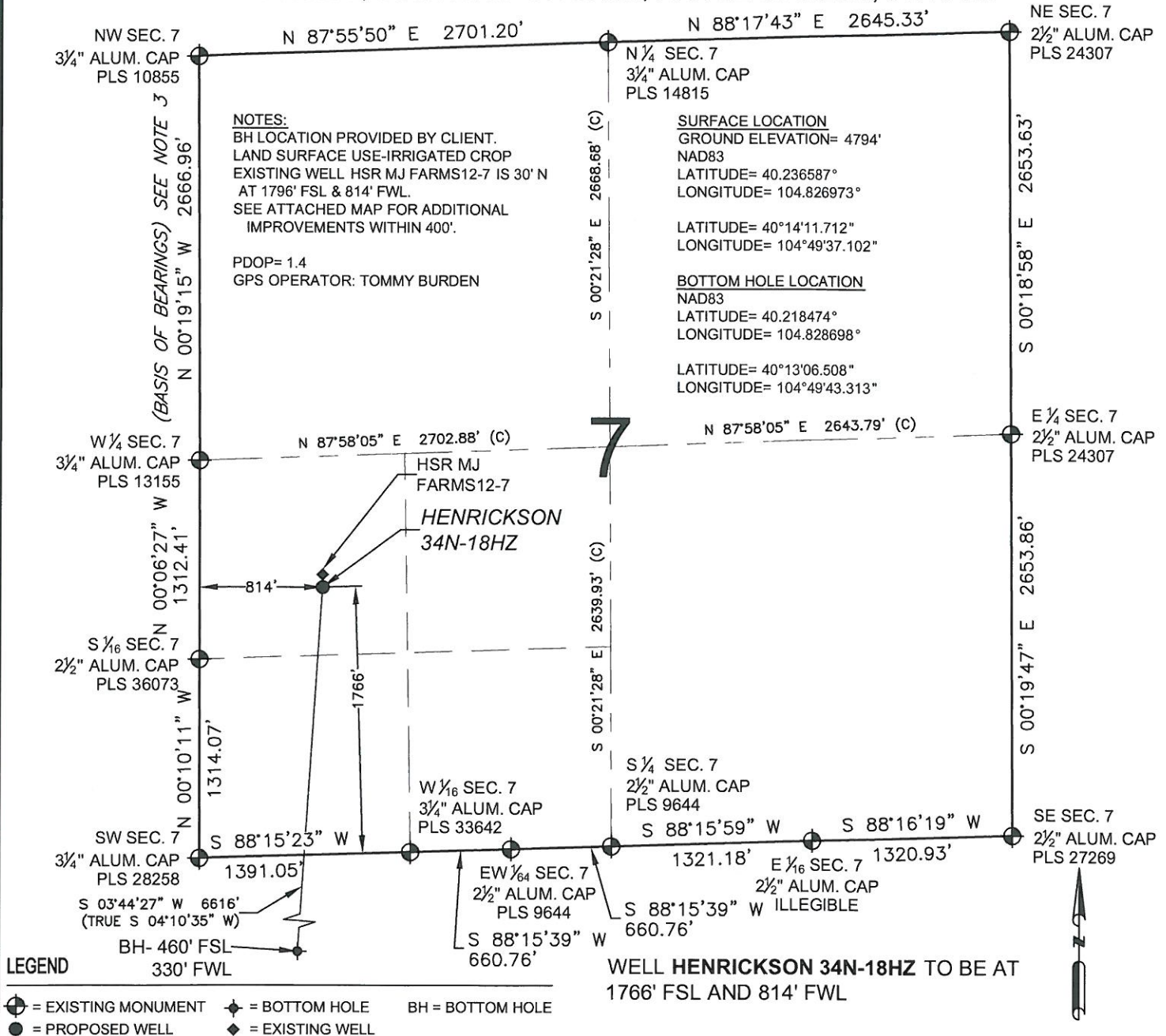


# WELL LOCATION CERTIFICATE: HENRICKSON 34N-18HZ

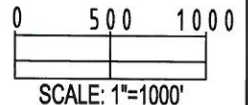
- = EXISTING MONUMENT

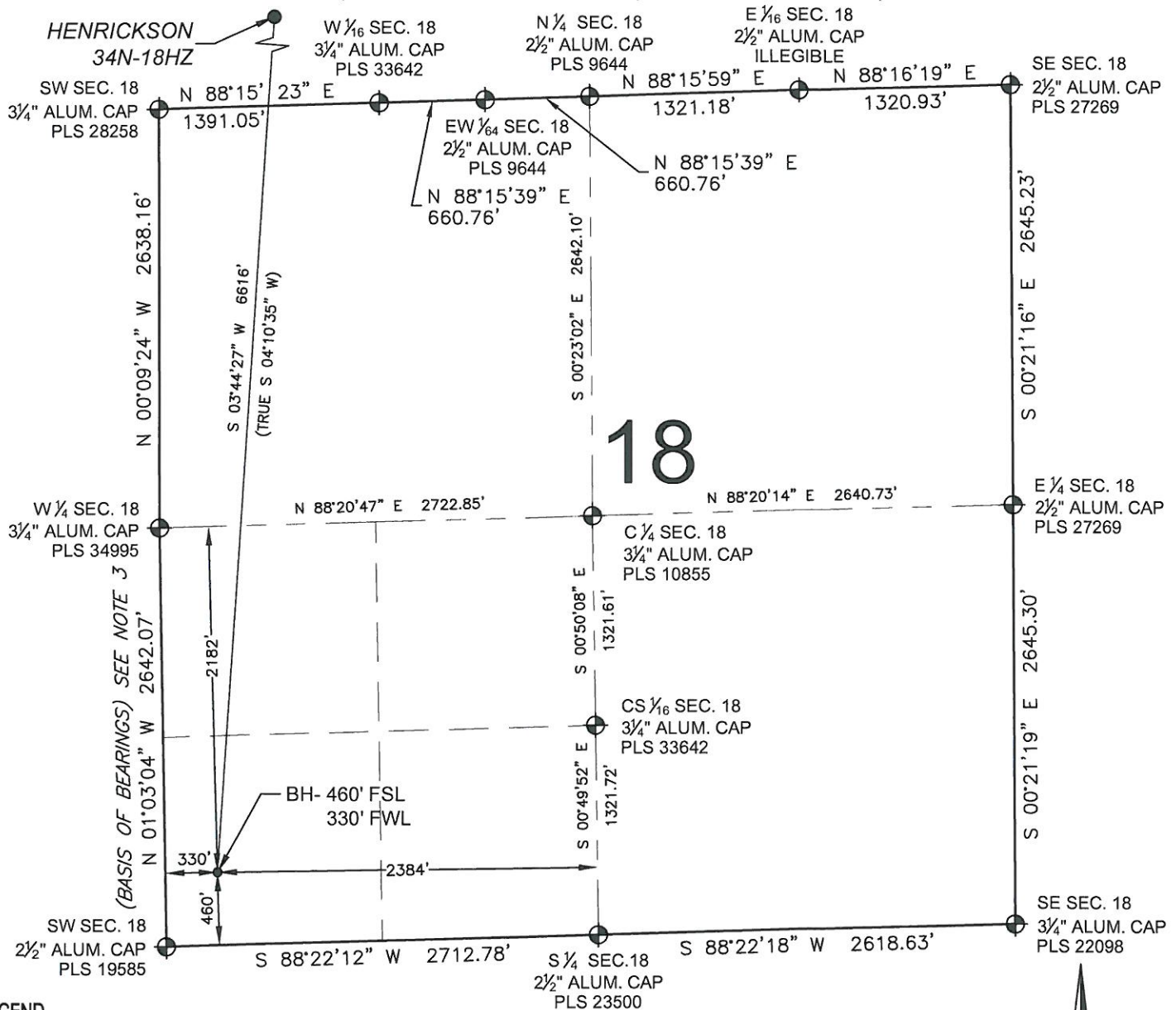

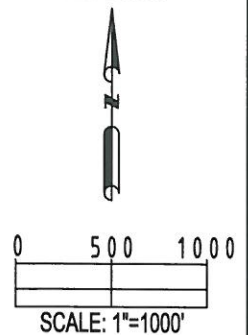
