Drilling/Completion Operations	<ul style="list-style-type: none"><li>-Light sources will be directed downwards and away from occupied structures during drilling operations.</li><li>-Completion operations will be minimal as fracture stimulation is not necessary for our target formations in Adams and Washington County wells.</li><li>-Noise and the numbers of days with equipment on site will be minimized due to completion techniques.</li><li>-Once the drilling and completion rigs leave the site, there will be no permanently installed lighting on site.</li></ul>

Site Specific	<ul style="list-style-type: none"> <li>-The facilities separation &amp; oil storage equipment plus evaporation ponds will be fenced to restrict public and wildlife access. This includes the facilities and evaporation ponds.</li> <li>-The well site locations, facilities and the roads will be kept free of noxious weeds, litter and debris.</li> <li>-Spraying for noxious weeds will be applied as needed.</li> <li>-Operator will manage all facilities such that secondary containment berms and evaporation ponds are within the specifications set forth in the COGCC rules.</li> <li>-Gates and fences will be constructed and maintained where necessary.</li> <li>-Any lease roads used by operator, its employees, or contractors will be graded and maintained such that water can drain properly.</li> </ul>
