





In accordance with a request from MARK ALESSI with PDC ENERGY Lat40°, Inc. has determined the surface location of the ALLES 22S-432 to be 2151' from the SOUTH line and 572' from the EAST line as measured at right angles from the section lines of Section 22, Township 5 North, Range 65 West and the bottom hole to be 2326' from the SOUTH line and 500' from the EAST line as measured at right angles from the section lines of Section 23, Township 5 North, Range 65 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 3/20/2013, for and on behalf of PDC ENERGY. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.




