I've completed my review of the referenced Form 2A and I have a comment on it.

Due to the proximity of several irrigation ditches to this oil and gas location as shown on your Hydrology Map, I'd like to add the following Condition of Approval.

"Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limit to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect the irrigation ditches located 174 feet west, 189 feet west, 233 feet south, and 316 feet south of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products."

Hi Doug,

I wanted to follow up with you on the COA that you added to the Maxey 24Q-HZ Pad. Listed below is information that I received from our field landman.

Maxey 24Q-HZ:

PDC will take out the small (cement irrigation ditch) to the west of the wells and tank battery. The ditch that is to 233' south and 316' south is a barrow ditch which is on the north and south of every county road in the county. We're not planning on doing a dirt berm or any site specific best management practice on this location to the south.
