COMMENTS:

Well was plugged fall of 2012. Due to road restrictions of Forest Service Lands. Wellhead was not cut-off and abandonment was not completed. Piceance Energy II, proposes to complete the abandonment by:

1. Cutting off the wellhead below ground level.
2. Verify the cement level inside the surface casing and surface casing/longstring annulus
3. If the cement is below 5' we will top it off with redi-mix cement.
4. Weld-on a plate and dry-hole marker in compliance with the BLM regulations.
5. Submit final abandonment sundries to both agencies.

Location will not be recalimed due to Piceance Energy's ongoing plans and corrdination with the Forest Service to re-permit a new well on the site.
