The 7" csg cement squeeze did not hold pressure, according to Kevin Hejl (Chevron, 970-250-9554) on 6/26/2013. The 9-5/8" by 7" casing annulus was cemented to surface prior to running the 5-1/2" casing described in this Sundry Notice.
