COMMENTS:

Noble Energy respectfully requests to move the BHL of this well in order to create a vertical pilot test hole for scientific purposes. This well will be drilled to the Niobrara formation, cored and logged, and plugged back, as detailed in the procedures below. A future horizontal Niobrara well will be permitted as a planned sidetrack based on the results of testing. We will not produce hydrocarbons from this pilot test hole. Plat and directional plan (showing verticality) attached.

Plug Back Procedure:**1) Pump Abandonment Cement Plug 1 (6831' to 6281'):**

- 40 BBLS 13.5 PPG water based tuned spacer
- 210 sks 15.8 ppg plug cement (43 BBLS)
- 5 bbls 13.5 ppg water based tuned spacer
- Displace with mud and POOH to 6231

2) Pump Kick Off Cement Plug 2 (6231 to 5681):

- 40 BBLS 13.5 PPG water based tuned spacer
- 260 sks 17.5 ppg plug cement (43 BBLS)
- 5 bbls 13.5 ppg water based tuned spacer
