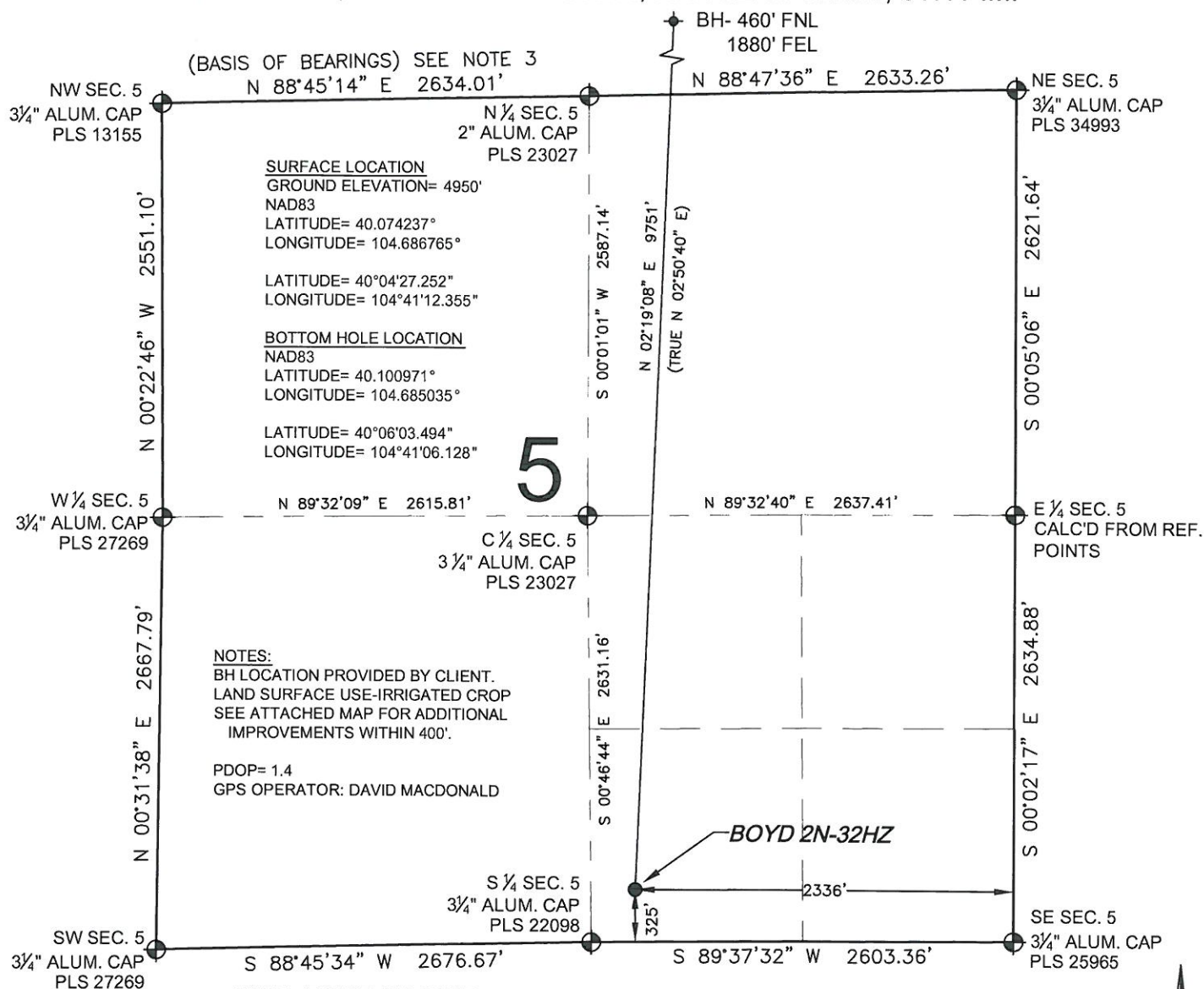


WELL LOCATION CERTIFICATE: BOYD 2N-32HZ

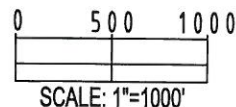
- ⊕ = EXISTING MONUMENT ⊕ = BOTTOM HOLE

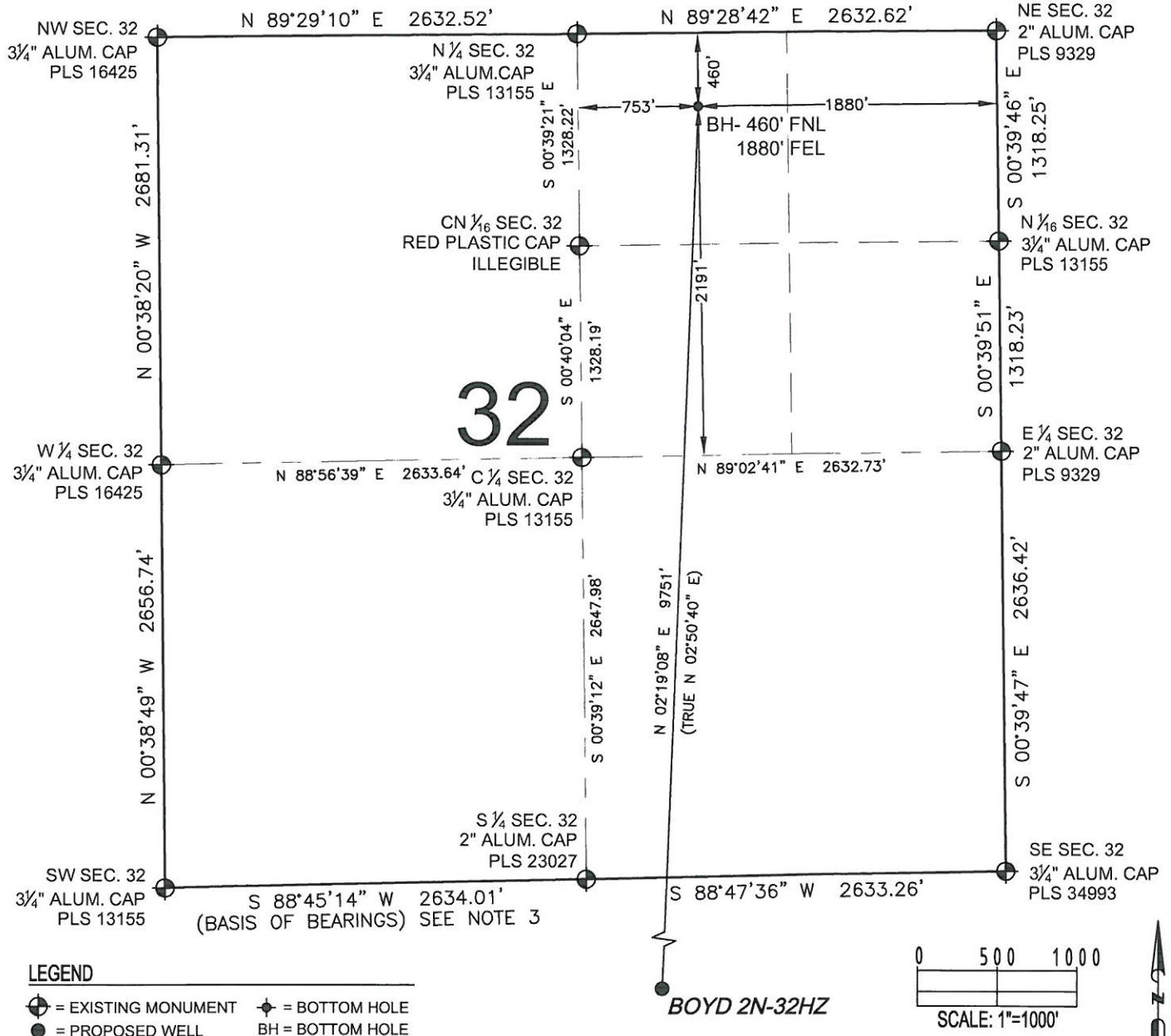
