SWEPI will be using a 3 string design for this well. We are requesting permission to change the intermediate casing depth from 2855'MD to now be 2301'MD. Top of Cement in the intermediate section will change from 250'MD to now be 1500'MD.

Please note that the TD of this well will now be significantly shallower than what was previously approved. Previous approved for 6392', new TD is proposed for 5699'. This shallower depth will be reflected in the Form 5.
