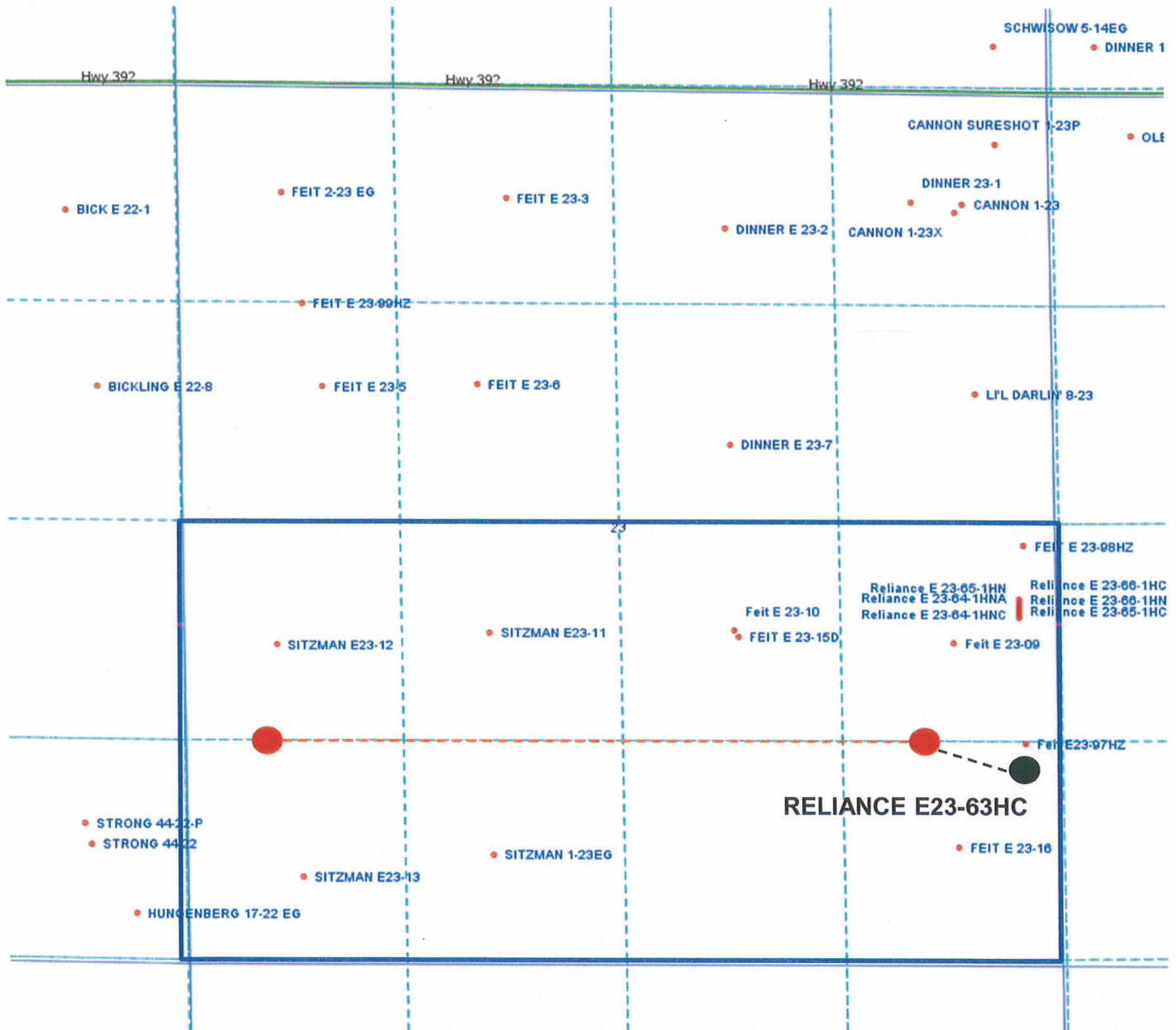

Proposed 322.07± acre spacing unit



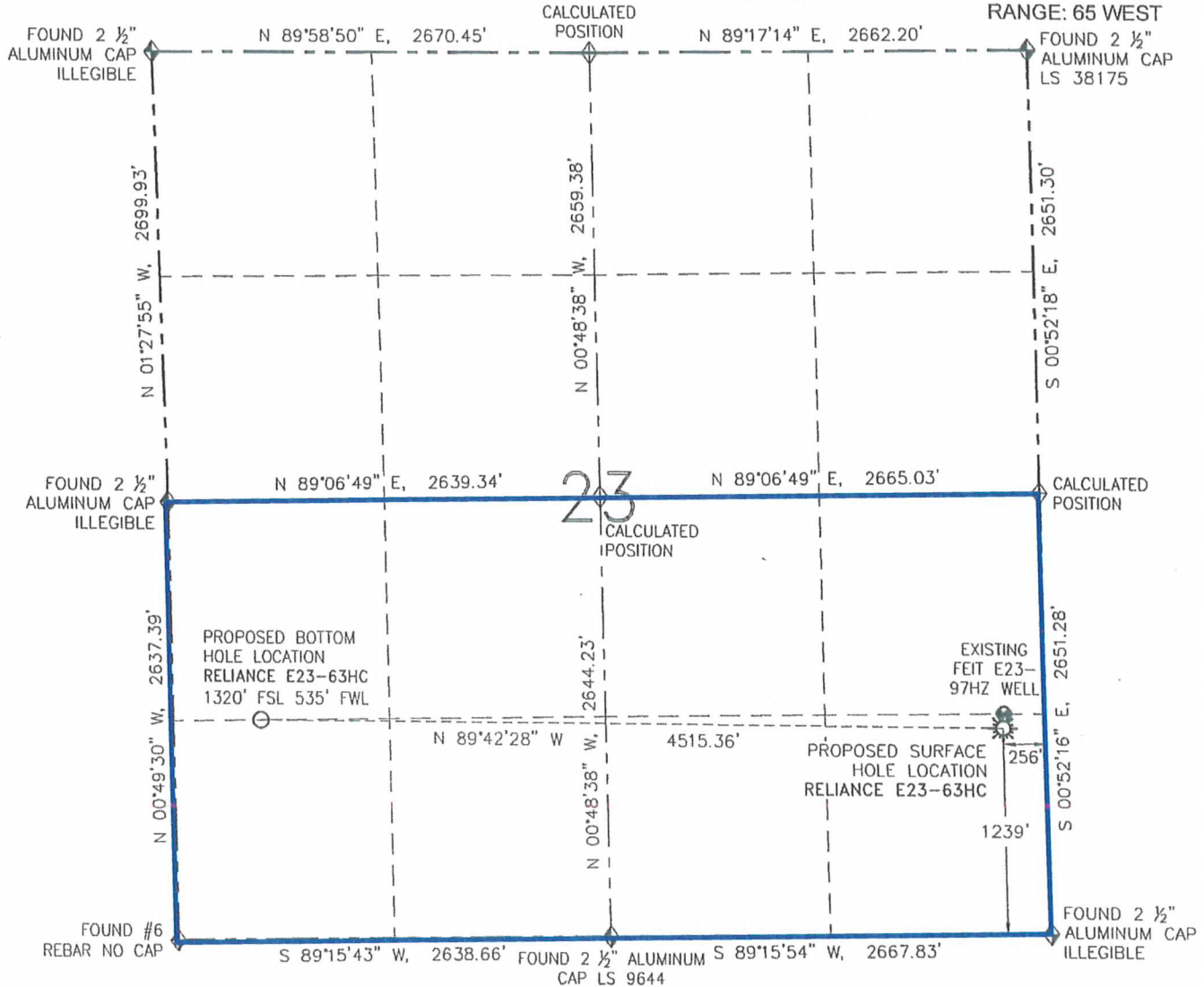
