This permit is to sidetrack the well to restore the originally permitted HZ lateral after completing testing of the pilot hole. The SHL and BHL does not change from what was originally permitted. The casing point changes from 1650 FSL, 723 FWL to 1520 FSL, 873 FWL. The TMD changed from 11406 to 11237. There are no other material changes to what was originally permitted.
