Operator Comments:

The CBU DV01D-11 A11 2100 is located in the Cathedral Bluffs Unit. During drilling operations on this well, difficulties with steerability and EM signal were encountered once we reached the Prairie Canyon formation. At 9,281', we tripped for a pulse tool and new 8-3/4" BHA. The 1.83 degree bend on the new BHA should have yielded build rates of up to 10 deg/100' to get us back on the original target line. However, expected build rates were not seen in the 1,178' of drilling to our first core point at 10,459'. With the drilling conditions stated we were unable to keep the wellbore directed towards the original BHL. The new BHL will make the distance to the external unit boundary approximately 4,016'. The nearest internal unit boundary distance is now approximately 8,700'. Please note Encana is currently drilling this well and would appreciate a timely reponse to this sundry notice.
