Greg-

Synergy Resources Corporation to the questions presented by Weld Air and Water - dated July 11, 2013 to Director Lepore

- 1) An evacuation plan in the event of an emergency would be Reverse 911- all residents should insure they have a number registered with 911 if they don't have a land-line
- 2) All equipment on the locations is state-of-the-art to insure we meet the Emission standards of all regulatory Agency's that monitor Operators in Colorado
- 3) The Site will be developed with Automation equipment that communicates to our Field operators 24/7. If a situation occurs- the location automatically shuts itself in and notifies SRC personnel immediately
- 4) Air quality is monitored through the State-of-the-art equipment and Automation, along with a contract third party Environmental Group that we send out quarterly to all of our locations with an infrared camera and detection equipment to insure the location is safe and performing to State and Federal standards
- 5) Comment is the same as #4

As I stated in our conversation earlier today- we request you keep our Kelly Farm / Northridge permits moving through the process-

Synergy has reached out to Julie Boyle and WAW- and invited her and her group to visit our location with our representatives and third party Environmental contractors to learn how we operate- she said she would get back to me in a few days-


