Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the SE/4SE/4 Section 34, Township 3 North, Range 64 West E/2E/2 Section 3, Township 2 North, Range 64 West E/2NE/4 Section 10, Township 2 North, Range 64 West, creating a 279-acre wellbore spacing unit for the Niobrara formation. NEI is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A(l).e(6). 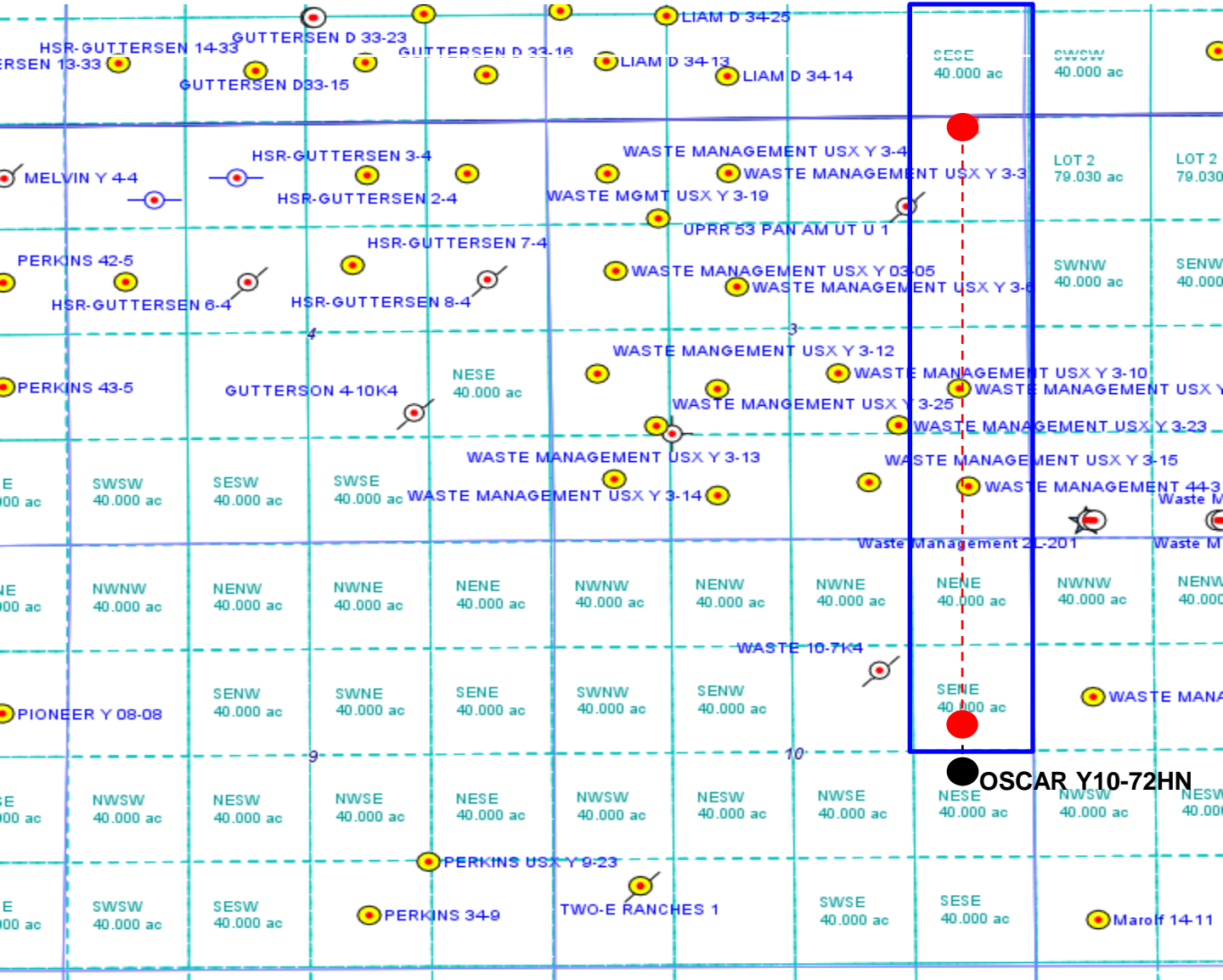

Proposed 279.12± acre spacing unit



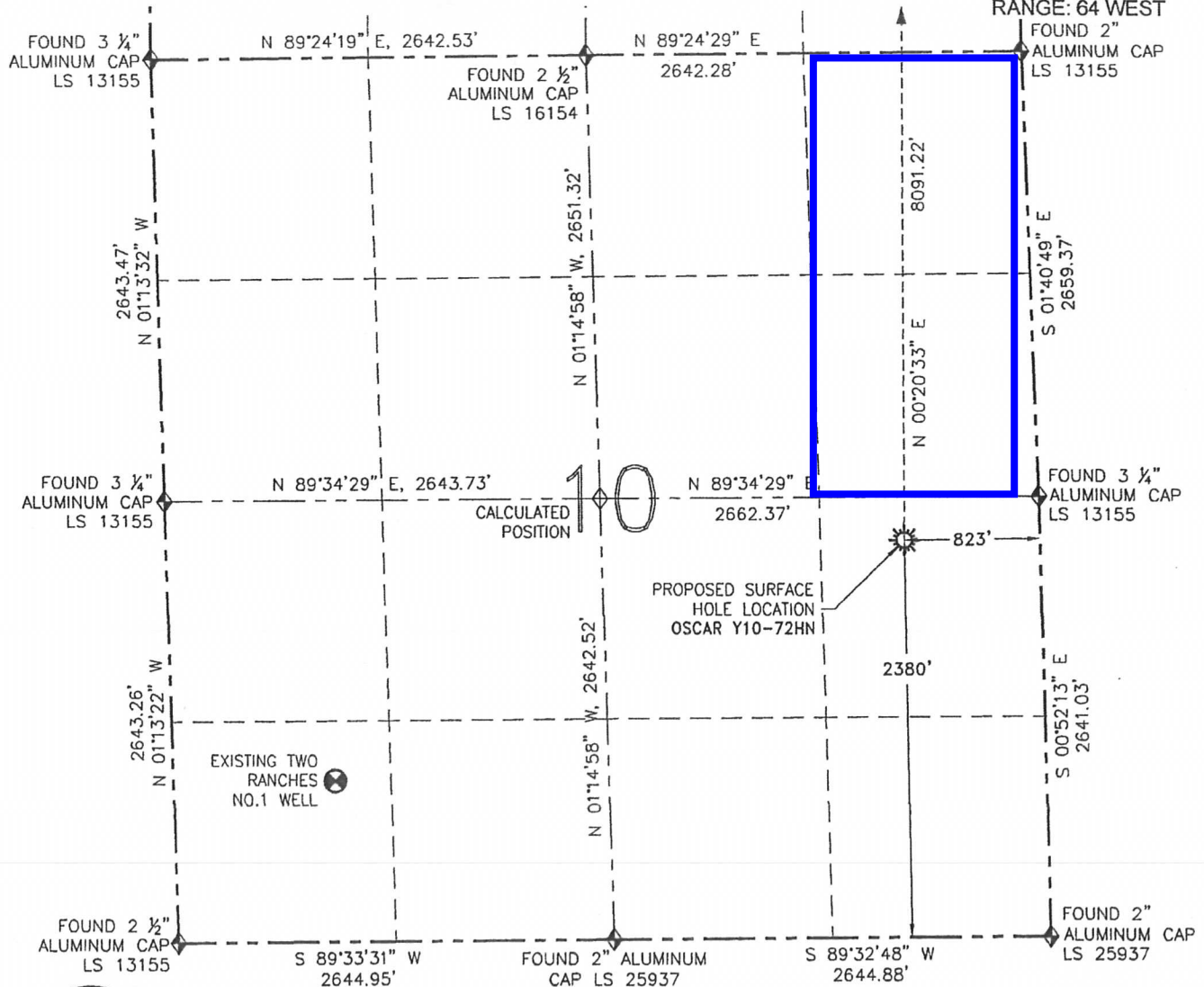

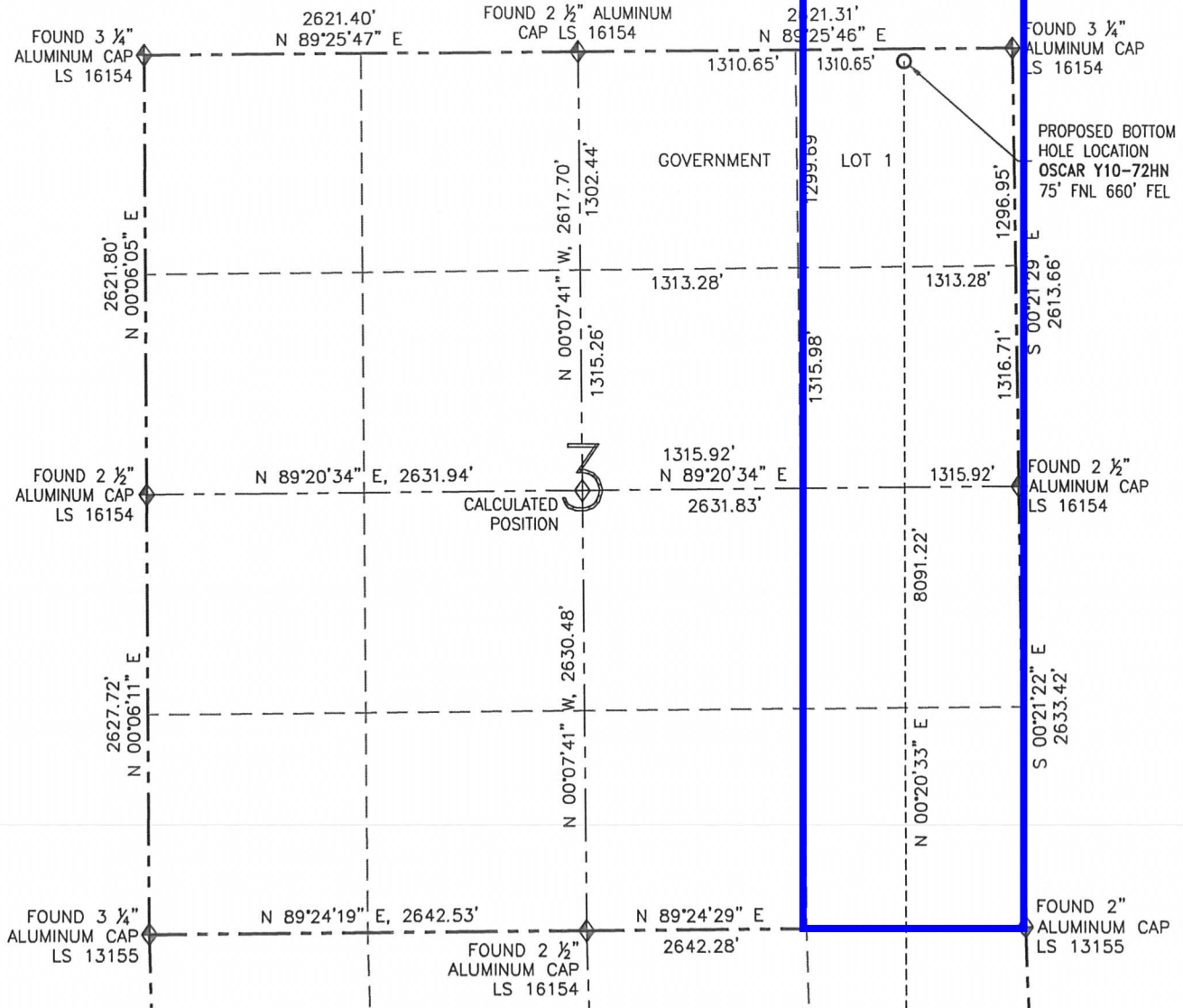
