Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the Sec 4: E/2E/2, Sec 3: W/2W/2, T3N, R64W, creating a 317-acre wellbore spacing unit for the Niobrara formation. NEI is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A(l).e(6). Copies of the required notice letter(s) is/are on file at the NEI offices. The required thirty (30) day notice period has elapsed absent the receipt by NEI of an objection to said proposal by the owner(s) within the proposed spacing unit for this well.

- Map & plat illustrating proposed wellbore spacing unit.

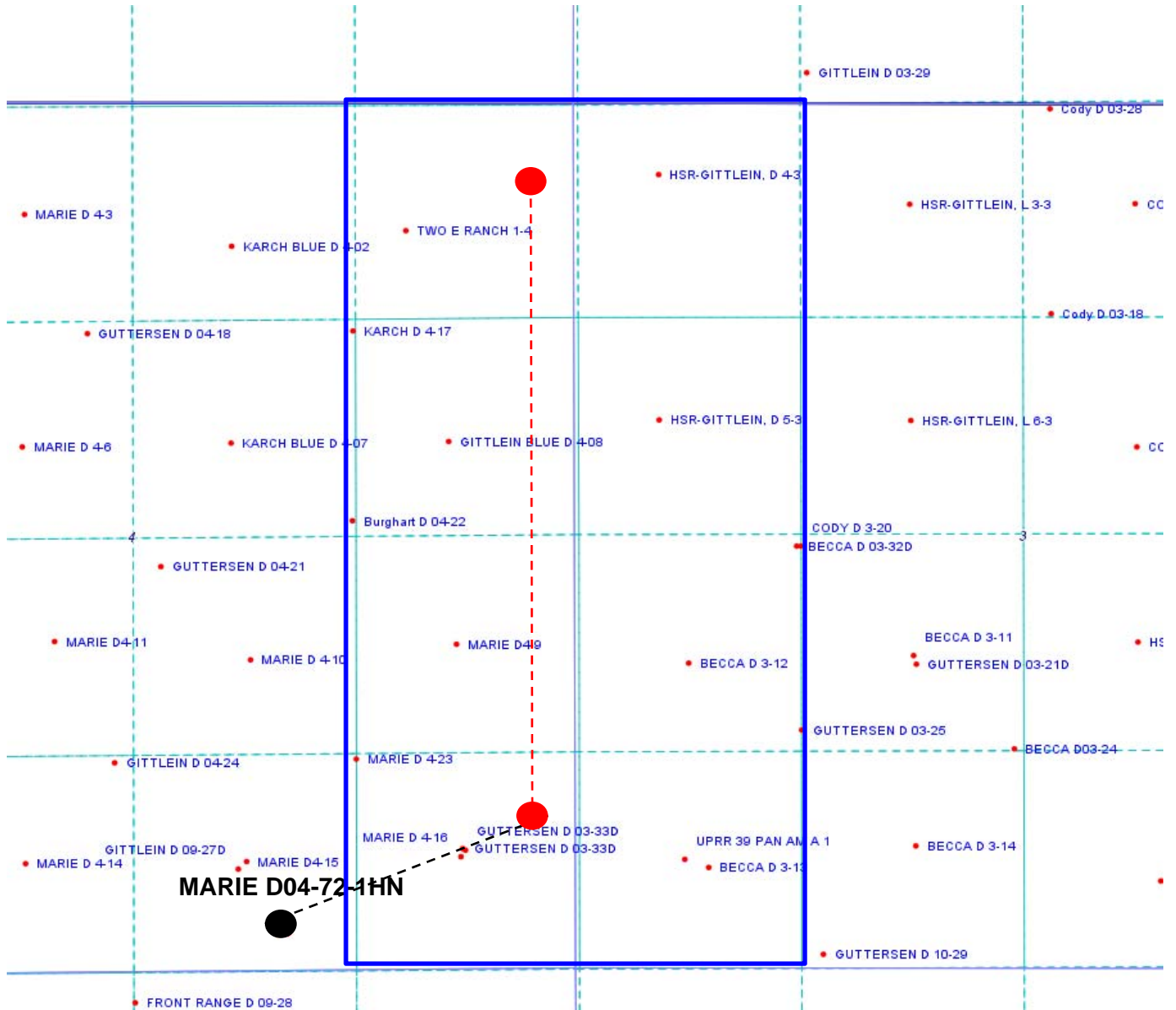
Thank you for your attention to the enclosed. NEI respectfully requests that the COGCC review the enclosed information and approve the Application for Permit to Drill the captioned well.

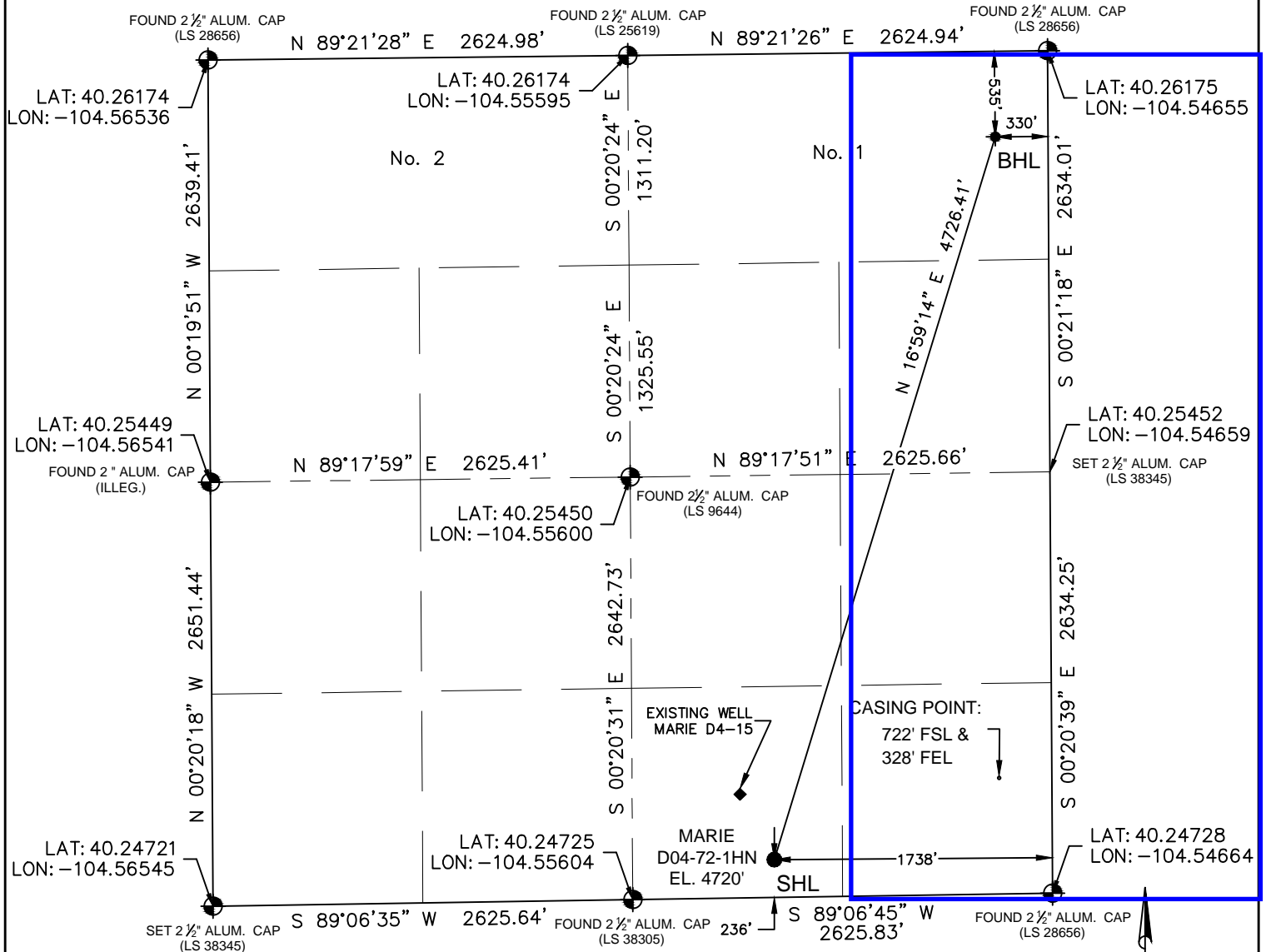
Proposed 317.06± acre spacing unit

In accordance with a request from Derrick Worden with Noble Energy Inc. Petroleum Field Services, LLC has determined the surface location of the MARIE D04-72-1HN to be 236' from the SOUTH line and 1738' from the EAST line and the bottom hole to be 535' from the NORTH line and 330' from the EAST line as measured at right angles from the section line of Section 4, Township 3 North, Range 64 West of the Sixth Principal Meridian, County of WELD, State of Colorado.

Notes:

- 1) Bearings shown are Grid Bearings of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983/2007. The lineal dimensions as shown herein are grid distances based upon the "U.S. Survey Foot."
- 2) Ground elevations are based on an observed GPS elevation (NAVD 1988 DATUM).
- 3) NEAREST EXISTING WELL IN SECTION 4 IS: MARIE D 4-15, 462' NW
- 4) IMPROVEMENTS: See LOCATION DRAWING exhibit for all visible improvements within 400' of disturbed area.
