Please find the Second Quarter 2013 groundwater monitoring and remdiation results attached.
Benzene concentrations in MW-1 continue to slightly exceed the 910-1 requirement of 5 ug/L. WPX Energy is proposing to utilize Deep Earth Technology Incorporated (DTI) Cool-OxTM in-situ chemical oxidation process to remediate the remaining hydrocarbon contaminants by treating groundwater directly through the MW-1.
