1) Water well permit # 1026 is the closet water well with a static water level of 8'. This well is $\pm 4465'$ away from the proposed referenced well head. 2) Nearest Surface water is due east $\pm 250'$ to the center of the water ditch. COGCC "River-Streams" map layer shows the ditch closer than it actually is as per the aerial image and the COGCC Topo Map layer. 3) A temporary completions area approximately four acres will be utilized for up to 3 fresh water storage tanks to be used during completions operations. This area will be completely reclaimed. Please see attached map. 4) This is an amended location. Please use new name of Minch 4H-L368. Well pad is moving $\pm 300'$ North East of existing approved permitted location; location size will approximately double in acreage disturbed.
