Details of work:

Control well w/ kill fluid. RIH w/ blade bit, and scraper, 233 jts. Tagged fill at 7115' KB. TIH w/ RBP, retrieved head, 219 jts 2 3/8" tubing. Set RBP @ 6670' KB w/ 219 jts. Pressure test to 1500#. Roll hole. Unland casing. Pick Up mule shoe and TIH w/143 jts of 1 1/4" to 4507'. Test lines to 50 psi. Pump 200 sks of 50/50 POZ at 13.5 ppg from 4468' up to 4120'. Pumped 350 sks of "G" neat 15.8 ppg cement from 670' to surface. Bond log from 5000' to surface. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Land 2 3/8" 4.7 # J-55 tubing to 7051' KB. Rig down and move off.
