

PROCEED IN AN EASTERLY, THEN NORTHERLY, THEN NORTHEASTERLY, THEN SOUTHEASTERLY, THEN EASTERLY DIRECTION FROM RANGLEY, COLORADO ALONG HIGHWAY 64 APPROXIMATELY 36.1 MILES TO THE JUNCTION OF THIS ROAD AND PICEANCE CREEK ROAD / COUNTY ROAD 5 TO THE SOUTHWEST; TURN RIGHT AND PROCEED IN A SOUTHWESTERLY, THEN SOUTHEASTERLY, THEN SOUTHWESTERLY DIRECTION APPROXIMATELY 18.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 26 TO THE SOUTHWEST; TURN RIGHT AND PROCEED IN A SOUTHWESTERLY DIRECTION APPROXIMATELY 1.6 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 29 TO THE SOUTH; TURN LEFT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 0.7 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 87 TO THE SOUTHEAST; TURN LEFT AND PROCEED IN A SOUTHEASTERLY, THEN SOUTHWESTERLY DIRECTION APPROXIMATELY 0.7 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 69 TO THE SOUTHEAST; TURN LEFT AND PROCEED IN A SOUTHEASTERLY, THEN SOUTHWESTERLY DIRECTION APPROXIMATELY 4.7 MILES TO THE BEGINNING OF THE PROPOSED ACCESS ROAD TO THE NORTHWEST; FOLLOW ROAD FLAGS IN A NORTHWESTERLY, THEN NORTHERLY, THEN NORTHWESTERLY DIRECTION APPROXIMATELY 1,747' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM RANGLEY, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 62.1 MILES.
