BRADENHEAD TEST REPORT

Step 3. Conduct Bradenhead test. Step 4. Conduct intermediate casing test. Step 5. Send report to BLM within 3 days and to OGCC within 10 days. Include wellbore diagram if not previously submitted or if wellbore configuration has changed since prior program. Attach gas and liquid analyses if sampled.

Comments: Surface casing produced 80 gallons of H2O in 3.5 hours of blowing down SC for re-plumb. Had to shut SC in after 20 min into test to empty tank. SC would blow down to 53#s and then start making H2O and start building pressure back up.
