Attached with this Form 4 submittal are the analytical laboratory reports for the MV 25-17 Treatment Area #1 batch 6 and Treatment Area #2 batch 8 confirmation samples.

Treatment area samples were collected in accordance with the approved Soils Management Plan (COGCC document #2232630).

Treatment Area #1 Batch 6 sampling:

Note that the as-built Treatment Area #1 consists of 8 active cells and not 12 as originally anticipated when the Soils Management Plan was submitted to COGCC (COGCC document #2232630).

Two grab samples were collected from the middle of sample grids number 1-2 and number 1-4 (25% of overall treatment area) in Treatment Area 1, and analyzed for BTEX, PAHs, and TPH. All constituents tested below the COGCC 910-1 requirements.

Treatment Area #2 Batch 8 sampling:

Treatment Area #2 consists of 12 active treatment cells.

Three grab samples were collected on 7/29/13 from the middle of sample grids number 2-6, 2-8, and 2-10 (25% of overall treatment area), located in Treatment Area 2 and analyzed for BTEX, PAHs, and TPH. All constituents tested below the COGCC 910-1 requirements except for TPH. The Treatment Area 2 was treated for hydrocarbons in accordance with the approved Soils Management Plan and resampled on 8/19/13. Three grab samples were collected from the middle of sample grids number 2-2, 2-4, and 2-8 and analyzed for TPH which tested below 910-1 requirements.

Based on these results, WPX Energy requests COGCC's permission to return the material from Treatment area #1 and Treatment area #2 for the purpose of reclamation of the excavation.
