## COMMENTS:

WPX Energy requests authorization to place a permanent pump and pump building at the RGU 23-6 297 well pad to support our injection operations in the Ryan Gulch area. The structure and pump will be placed on an existing, non-reclaimed portion of the pad and no additional disturbance is expected (see attached site plan). Water will be pumped from the existing, approved, facilities at the RGU 23-6 297 well pad via existing, approved, pipelines to the Mautz Ranch facility for injection. An automated system will be installed that will incorporate real time data acquisition in order to control, monitor and track pump pressure and volumes. Installation of the permanent pump and structure will begin upon receipt of BLM, State and County approvals. This authorization will be needed for the life of the field and could exceed 30 years.
