Oxy would like to obtain approval from the BLM to use previously stockpiled soils on location at the Logan Wash 28-10 Offloading Facility for general facility road maintenance, structural bolstering and grading. Approximately 80 cubic yards of soil was placed on lined containment in July of 2012 (please see attached InterTech document) due to an underground produced water pipeline failure which was reported to the BLM on 6/21/2012 and the COGCC on 6/19/2012. As part of closure, Oxy is requesting to incorporate the stockpiled soils into facility maintenance activities, based on the sample data. Oxy pulled samples of those soils and has verified that the only exceedances are EC and SAR (please see attached sample analysis report from ESC Lab). The elevated EC and SAR will be addressed at final facility closure.

Based upon Sundry approval, Oxy will request COGCC closure.

SUNDRY NOTICE - SURFACE USE CONDITIONS OF APPROVAL
July 17, 2013

All Stipulations and Conditions of Approval (COAs) associated with the approval of Facility Logan Wash 28-10 Offloading Site remain in full force and effect, unless superseded here.

1. Before any material is used at the site, Oxy shall install a Stabilized Construction Entrance (SCE) at the southern gate of the facility such that all spills and storm water are contained to the facility pad and prevent surface runoff or spills from migrating off site. The salt contaminated material shall not be used to construct any SCE.
2. Oxy shall maintain, through the life of the facility, maintain SCEs at both entrances of the facility such that all spills and storm water are contained to the facility pad and prevent surface runoff or spills from migrating off site.
