COMMENTS:

During drilling of the well production lateral a fault was encountered at approximately 2,700' MD which resulted in the wellbore coming in deeper than prognosed in the formation and missing the targeted Wolf Mountain Bench at 3,500' MD. It is not expected to be able to drill back into the bench and a sidetrack is needed to reach the targeted bench. The plan is to place one 500' class G cement plug at the heel of the well from 2,00' to 2,400' MD, this plud will be tagged to verify location. Another 500' class G cement plug will be placed above this from 2,400' to 1,900' to be used to perform an open hole sidetrack.
