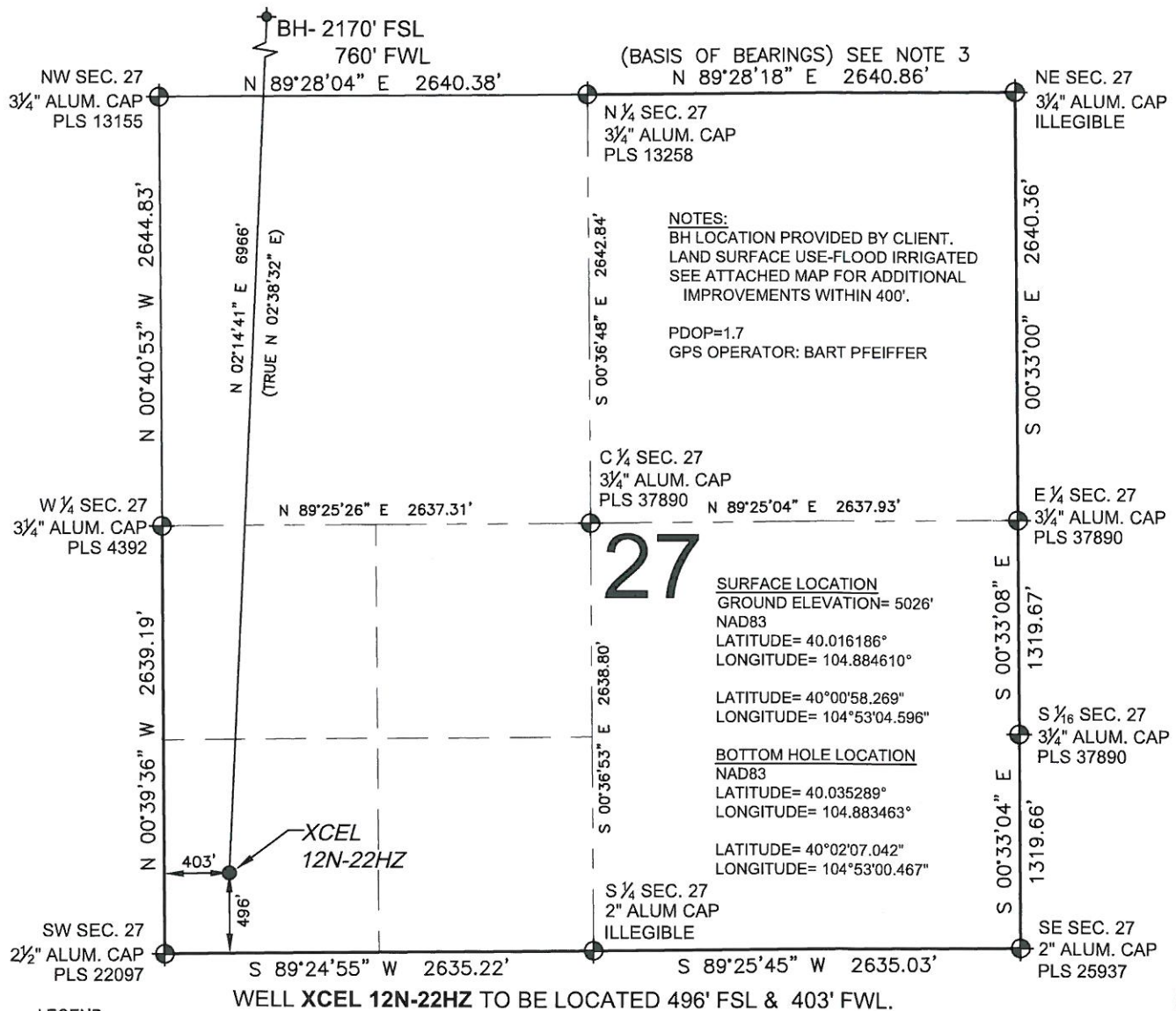


WELL LOCATION CERTIFICATE: XCEL 12N-22HZ

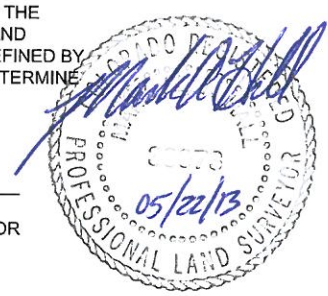
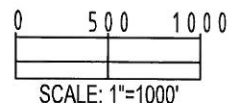

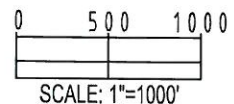
