COMMENTS:

There were two Form 2's submitted and approved for the above mentioned well. One Form 2 was to drill a vertical pilot hole to 8757' with conductor, 9-5/8" & 7" casing. The second Form 2 was permitted to drill a lateral to 10,906' with a 4" liner set @ 10,906'. The operator would like to request that this well be drilled and produced in the permitted and approved pilot hole. The new proposed TD is 9800'. The 7" casing will be set @ 7805' and cemented to surface. A 4" un-cemented perforated liner will be ran to 9800' TD. The top of the liner will be @ 7600' and the bottom of liner @ 9800'.
