Hi Angela,

Colorado Parks and Wildlife (CPW) has reviewed the submitted Form 2A for WPX's Federal RG 24-29-298 pad location. Listed below are wildlife concerns and best management practices (BMPs) in addition to the BMPs already supplied by WPX. Please let me know if WPX is in concurrence with these BMPs or if there's a need to discuss them further. If they look acceptable I'll get our end of the 2A approved ASAP. Thank you.

Location: T2S, R98W, Section 29 (39.842915, -108.420694)

Wildlife Concerns: The proposed pad location is within elk production area sensitive wildlife habitat (SWH). This area is also used by elk and mule deer as part of their migration route

between summer and winter range. Given these wildlife concerns, CPW recommends the following BMPs for your consideration at this location:

1. Establish company guidelines to minimize wildlife mortality from vehicle collisions on roads. Slow speeds and increased awareness among employees and contractors traveling to and from the site should help to reduce impacts.
2. Establish a systematic and thorough noxious and invasive weed monitoring and treatment program for all disturbed areas.
3. Reclaim mule deer, elk, and pronghorn antelope habitats with native shrubs, grasses, and forbs appropriate to the ecological site disturbed, avoiding aggressive non-native grasses and shrubs.
