As a follow-up to our phone conversation this morning, I am requesting approval from COGCC Engineering for a plug back of the curve section of the Harris 38N-18HZ and sidetrack of the same. The PBHL of the well will change from a TVD standpoint, as we intend to change our target to the Niobrara C bench as opposed to the Niobrara B as previously planned. Well specifics are as follows:

Harris 38N-18HZ
API 05-123-37639
Weld County, CO

Current well depth is 7,575' MD (estimated 7,148' TVD). Our plan is to plug back to the vertical section of the hole from where we were able to back off our 7" casing at 5390' MD to 5200' MD/TVD and kick off of a dual cement plug.
