

**MEMORANDUM OF  
SURFACE USE AGREEMENT**

This Memorandum of Surface Use Agreement ("Memorandum") is made and executed as of the 20<sup>th</sup> day of June, 2013 to evidence that:

The Surface Use Agreement ("Agreement") dated the 20<sup>th</sup> day of June, 2013 was entered into by and between Puckett Land Company whose address is 5460 South Quebec St, Suite 250, Denver, Colorado 80111 ("Owner") and WPX Energy Rocky Mountain, LLC whose address is 1058 County Road 215, Parachute, Colorado 81635 ("Operator"), with Owner and Operator collectively known as the "Parties," which, among other provisions, provides as follows:





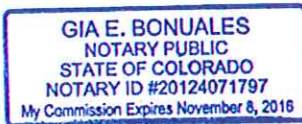
