CoP is notifying the intent to flare/combust gas at this location using an enclose combustor. The nearest pipeline is located 5,933' from location and construction of the flowline has not been completed. The daily mcf that would be flared/combusted would be 260 mcf/day for a total of 94900 mcf/year. The analytical attached shows that H2S concentration in the gas is 5 ppm.
